### Killearn Community Action Plan

#### This Community Action Plan sets out the priorities for the development of

Killearn over the next ten years as determined by the community through an extensive process of community engagement carried out over a six month period in 2014.

- Our main likes and dislikes as identified in our Resident Survey
- · Our Vision Statement for the future of Killearn
- The main priorities for action
- · Information on how you can stay in touch and become involved

This Community Action Plan has been produced by a Working Group of Killearn Community Futures Company with assistance from the Communities Engagement Team of Stirling Council and updates the first Community Action Plan produced in 2003. Many of the targets of that first plan have been achieved and it was considered time to produce a new plan that reflects the opinions and aspirations of the residents of Killearn and its environs now and in the future.

Successes over the last 10 years have included:

- Village Hall fully refurbished & extended
- Playpark redesigned and installed
- Woodland Cemetery installed
- Local footpaths improved & maintained with a map of local walks produced
- Glen & Woodlands management plan put into operation
- Speed cameras & some road alterations installed
- "Colourful Killearn" supported
- Killearn Courier established
- Community Initiatives thriving: Hoolie, Country Market, 10K, annual firework display, Beer Festival, cultural and craft events
- Current development projects, including the Sports Pavilion initiative and Sustainable Killearn

We have also used the last Action Plan in making representation on behalf of the community to improve roads, housing and other service provision.

This Plan is for the whole community and is jointly owned by all the organisations and individuals that gave time to offer their views and took part in its preparation. We will be working together to ensure its implementation over the next ten years.

Evidencing Informing Influencing Improving



#### LOCATION

Killearn is situated in Strathendrick, the western rural area of the Stirling Council area. The village is surrounded by farmland and is located 2 miles from Balfron, 5 miles from Strathblane and Blanefield and the same distance from Drymen. It is midway between Stirling and Glasgow. It is in a scenic location overlooked by the Campsie Fells and has views of Loch Lomond.

#### **HEALTH & SOCIAL CARE**

The average health of the population of Killearn, as declared in the 2011 census is better than the average for Scotland with significantly more persons declaring that they have good or excellent health and fewer declaring that they have disabilities than in Scotland as a whole. The village has an excellent health centre and access to hospitals in Greater Glasgow & Clyde and Forth Valley Health Board areas. Stirling Council provides and arranges a range of social care services to support people in their own homes.

#### **EMPLOYMENT**

67.2% of the population are economically active. The number of commuters to Stirling and Glasgow is high, yet there is a level of economic activity in the village itself. The census identified around 105 people employed in full-time and part-time jobs within the Killearn area

#### **POPULATION**

The population of the Killearn Village Area is 1701 (source: 2011 Census Data). The main growth in Killearn occurred between 1971 and 1981 when the population expanded by over 60%. There has been slower but steady growth since then in accordance with the local plan. The population is comparatively unbalanced with significantly fewer in the 16 to 29 age group and significantly more in the over 60 age group compared with Scotland as a whole. The median age for both males and females is 48 in Killearn, compared with 40 for males and 42 for females in Scotland.

#### **TRANSPORT**

63% of households have 2 or more cars, with only 6% with no car or van. 74% use their car to travel to work, with only 2% using the bus and a further 3% using park and ride facilities. There is an hourly bus service to Glasgow and Stirling during much of the day on weekdays, with a much reduced service to Glasgow and no service to Stirling on Sundays

#### **HOUSING**

The village has 671 houses (source: 2011 Census Data), with approximately another 200 in the surrounding area. The level of owner occupancy is high at approximately 91% with 5% in council-rented property. The attractiveness of the area and its proximity to Glasgow and Stirling makes Killearn a highcost housing area.

#### SOCIAL AND COMMUNITY

Services and facilities in the community include:

- Primary school, playgroup, nurseries, childminders
- Nearby secondary education at Balfron High
- Shops, bank, post office, hotel and pub, both with restaurants, and three cafés.
- Abbeyfield House offering "very sheltered" housing to older people
- Killearn Health Centre
- **Veterinary Clinic**
- Killearn Kirk
- Tennis courts, football pitch and multicourt
- Village Hall and Church Hall
- Killearn Community Council
- Killearn Community Futures Company
- Killearn Trust
- Many local groups active in the community



This Community Action Plan was prepared following consultation within the community over a period of six months during 2014.

#### Consultation included:

- An article in the Killearn Courier
- An 'All-Village Get-together' meeting to introduce the proposed Action Plan and to engage the community in the process, which attracted an attendance of over 120, including young people
- A "community views" survey, which was compiled and delivered to every household and to the primary and secondary schools
- Inclusion of all local businesses and local councillors in the process
- Production of a full report on the results of the survey, which was delivered to every household and proposed a set of strategic priorities for development in the Community Action Plan
- An invitation to feed back on both the survey report and the proposed strategic priorities

#### The Survey asked five key questions:

- What is most important to you? (selecting 6 from a possible list of 11 themes)
- What are your three favourite things about our community?
- What three things would you change in our community?
- What would make our community a better place to:
  - Live in?
  - Work in?
  - Visit?
- · What special projects would you like to see developed in Killearn over the next 5 years?

Over 430 completed surveys were returned – some using an online form and others using paper copies. From these forms, we received over 4000 individual comments that we have sorted, categorised and analysed. The findings are set out in detail in the separate survey report, which was sent to all households in the village and can be found at <a href="https://www.kcfc.co.uk">www.kcfc.co.uk</a>.

The most highly prized asset of Killearn is its people; the friendliness of those who live here, the sense of community and the energy and commitment that people give to community events ranked top in the responses.

Also important for people is the locality – where Killearn is situated - within easy reach of cities and urban amenities whilst enjoying close proximity to a beautiful rural environment. People valued the setting of the village, the physical attractiveness of the village itself, the green spaces within the village and the nearness to the hills and felt a bond with these aspects. There was also general appreciation of the amenities of the village – the health centre, the school, the village hall and the shops.

These views and the aspects that people wanted to improve and develop have been used to inform the *Vision* for this Action Plan and the *Priorities* that will take this Vision forward.

#### The Vision and the Priorities



The Survey Report has provided a great deal of information to help us focus on the things that matter most to the people living in the parish of Killearn. It was evident that they fall into three broad categories:

- to preserve what is valued;
- to improve what is not meeting aspirations; and
- to **introduce** new things to the community.

This then informed the Vision for our Killearn Community Action Plan:

"Preserving and protecting what people value in Killearn, while making improvements that meet the needs and aspirations of our community"

After analysing the survey results, the following subjects appear to matter most to people and support the delivery of the Vision:

# Roads, traffic and transport

Lobby Stirling Council for improved road surfaces

Work with Stirling Council to consider suitable traffic calming measures

Lobby transport providers to improve frequency, condition and cost of buses

Work with community to improve parking options, maintenance and habits

# Environment and Heritage

Protect, maintain and improve green spaces

Protect and preserve areas of historical significance

#### Digital Connectivity

Work with providers to improve broadband speed, better mobile phone coverage and digital radio signals

Harmonise access to village websites

## Paths and Pavements

Lobby Stirling Council for improved pavements

Work with owners of unadopted pavements to improve surfaces and accessibility

Continue to support development and maintenance of walking and cycling paths

Explore ways to improve off-road connections to villages and walking routes (e.g. West Highland Way)

#### Community Involvement and Development

Encourage sustainability of community clubs and groups

Develop more community volunteering by wider sectors of the community

Encourage increased business development

Encourage tourism and associated services

Development of a central information hub for residents and visitors

#### Youth Issues

Explore ways to maximise use of the Village Hall youth facilities

Encourage adult volunteering to lead, organise and sustain youth clubs, groups and activities

Develop a wider range of sports facilities and opportunities

#### Housing Strategy

Explore and encourage development of Killearn Hospital Site for housing, business and leisure

Bring influence to future housing development to ensure they are both sensitive and affordable

#### Health and Wellbeing

Work with partners to maintain and improve leisure facilities in the village

Support the development of sports facilities and opportunities

Work with Police Scotland to maximise safety and security

Work with NHS Boards to keep hospital referral routes flexible to meet people's needs



The priorities in this Community Action Plan will be taken forward by a range of public, private and voluntary sector partners, including: Killearn Community Futures Company, Killearn Community Council, and other local community groups.
